2 I'm Donald Cappillino. I'm the Hearing
3 Officer in this matter and I now open the
4 public hearing.

5 Before the hearing began I had the
6 court reporter mark, into Evidence, as
7 Hearing Officer's Exhibit Number 1, the
8 notice of public hearing in this matter.
9 I had marked, in Evidence, as Hearing
10 Officer's Number 2, the affidavit of
11 publication from D. Davis from the
12 Poughkeepsie Journal indicating that the
13 notice of public hearing was published
14 once in the Poughkeepsie Journal on
15 September 27, 2018. I had marked as
16 Hearing Officer's Exhibit Number 3, in
