### **NEW BUSINESS**

A. For Consideration and Approval of a Final Resolution for T-Rex Hyde Park Owner, LLC and its related entity T-Rex/Shaner Hyde Park Hotel, LLC (Inn at Bellefield Project, Town of Hyde Park) authorizing an amendment to increase the sales tax exemption benefit in the amount of \$587,925 and to extend the Completion Date.

Chairman Dean addressed comments received about the minutes, comments from the public hearing for this project in regards to benefits being returned if projects did not spend its requested amount, and clarified his comments from the previous meeting about certain types of projects the board may want to request additional information or analysis. He also asked Ms. Lee to clarify a comment that was made about the 105 job verses 300 jobs.

#### Ms. Lee noted that:

- The 369 jobs is associated with the project in its entirety, with all phases, including the phases which are not included in the IDA project
- The IDA portion of the project just concerns the hotel, which is to create 105 jobs
- The remaining number jobs are associated with the other phases, the retail, the commercial, and the residential portions of the project, which are not part of the IDA project.

Mr. Mulroy noted that things are continuing to go forward and that they anticipate their construction lender will give them a green light to go forward in the next couple weeks and that costs for the building materials has increased tremendously.

A motion was made by Mr. Torreggiani, duly seconded by Mr. Doyle to Approval of a Final Resolution for T-Rex Hyde Park Owner, LLC and its related entity T-Rex/Shaner Hyde Park Hotel, LLC (Inn at Bellefield Project, Town of Hyde Park) authorizing an amendment to increase the sales tax exemption benefit in the amount of \$587,925 and to extend the Completion Date. Roll call vote was taken. All voted in favor and the motion was carried.
